## **1 SUBJECT OF THE CONTRACT**

- 1.1 The organizer is the host of the Online Conference entitled "Possibilities of Development of Ecotourism in the Košice Region" implemented online through the ZOOM platform, which will take place on February 25, 2021. The aim of the conference is to create a space for the exchange of experience in the field of ecotourism and sustainable tourism, to present the EcoVeloTour project and its outputs in the Košice region, including the Strategy for the Development of Ecotourism in the Košice Region. During the conference, the organizer is also interested in presenting examples of good practice from destinations from abroad.
- 1.2 The presenter has professional experience with ecotourism and sustainable tourism and is interested in cooperating with the organizer in the form of preparation and presentation of a case study of examples of good practice during the conference.
- 1.3 The presenter undertakes to send a presentation to the Organizer by February 17, 2021, as well as a short annotation to the content of the presentation.

1.4 The presenter undertakes to present his/her paper/presentation on the day of the conference, at the agreed time and the organizer undertakes to pay the presenter the agreed fee for this presentation of the ecotourism destination.

## **2 TERMS AND CONDITIONS OF THE COOPERATION**

2.1 The presenter will present the ecotourism destination online via Zoom, on **February 25, 2021** in the range of 15-20 minutes. Following the conference, the Organizer will collect the questions submitted to the discussion and send them to the presenter for answering. The presenter will additionally answer the questions asked in the discussion. Subsequently, the answers will be published on the Organizer's website.

2.2 The presenter will send the organizer an abstract of the presentation in advance, brief information about the presenter him-/herself by February 17, 2021, and will also send the final version of the presentation by February 22, 2021.

2.3 The presenter agrees with the publication of the presentation on the website of the Košice Region Turizmus and also with the provision of the presentation to the conference participants by e-mail.

## **3 REMUNERATION**

3.1 The organizer undertakes to pay the presenter for the presentation according to Art. 2 point 2.1 of this contract remuneration **in the amount of 80.00 EUR gross**.

3.2 The reward will be paid by the organizer to the account of the presenter specified in the header of this contract within 14 days from the date of the conference.

3.3 The parties agree that the remuneration includes the reimbursement of all necessary and useful costs incurred by the presenter to fulfil the obligations under this contract.

## **4 FINAL PROVISIONS**

4.1 The provisions of the Civil Code apply to matters not specifically regulated by this contract. This contract is governed by the law of the Slovak Republic.

4.2 Any amendments to this contract must be in writing and must be signed by both parties.

4.3 The contracting parties declare that the contract was not concluded in distress under noticeably unfavourable conditions, that they understood its individual provisions and that they are a manifestation of their real serious and free will and undertake to perform them voluntarily, which they confirm as a sign of consent with a handwritten signature.

4.4 The contract is made in two copies, one of which will be given to the presenter and one to the organizer.

4.5 The Agreement shall enter into force on the day of signature by both parties and shall take effect on the day following the day of its publication pursuant to a special regulation (Act No. 211/2000 Coll. on Free Access to Information and on Amendments to Certain Acts (Freedom of Information Act), as amended.
